# **LETTER - TOWN OF BLOOMING GROVE - REMOVING MAY'S FIELD DAM:**

**Mayor Bucco:** 

September 2<sup>nd</sup>, 2020

"Pleased by advised that pursuant to the Memorandum of Understanding between the Town and the Village, concerning the Community Development Block Grant Disaster Recovery Program. The Town expects to proceed with the work May's Field on or about September 28<sup>th</sup>, 2020. In addition, the Town expects to commence work on May's Field Dam on or about September 30<sup>th</sup>. We will follow up with the Village if any Assistance needed and moving forward with work. Please feel free top contact me in the office if you wish to discuss the matter."

They are going to be removing the dam, I think they will be completing it on the 30<sup>th</sup>.

Deputy Mayor Lang: We spoke about what this would do to water level downstream. It's only some rocks; not a huge dam.

Mayor Bucco: Our wells are upstream; I don't really see dam causing to many problems, they should take tree out of the way to take care of it.
