

A Village Board Regular Meeting was held on Tuesday, May 21, 2019 at 7:00 P.M. at Village Hall, 9 Fairlawn Drive, Washingtonville, New York.

PLEDGE OF ALLEGIANCE TO THE FLAG:

Mayor Joseph Bucco led the Pledge of Allegiance to the Flag.

MAYOR JOSEPH BUCCO – ANNOUNCEMENTS:

Mayor Joseph Bucco announced that the Village of Washingtonville Memorial Day Parade will be held on Monday, May 27, 2019. Line-up will begin at 9:15 A.M. at the Washingtonville Middle School Parking Lot.

The Mayor stated Veterans of Foreign Wars (V.F.W.) will hold services at St. Mary's Cemetery beginning at 8:30 A.M. followed by services at Washingtonville Cemetery and ending with services at Veterans Memorial Park monuments located across from Betty's Country Kitchen in the former Village Hall Parking Lot.

RESOLUTION – FACILITY USE REQUEST – SOLICITOR'S PERMIT - DOGFELLAS, LLC.:

APPLICATION – SOLICITOR’S LICENSE – FRUIT FASHIONS:

An application for a proposed Solicitor’s License regarding the selling of fresh fruit from a truck in Autozone parking lot was denied by the Village Board due to Village of Washingtonville Codes. The Village Board will conduct further research regarding this matter.
