<u>ITC CONTRACT – NEW COMMUNICATION SYSTEM – VILLAGE POLICE STATION –</u> <u>POLICE CHIEF BRIAN ZACCARO:</u>

Trying to upgrade phone system; Keith is on call w/us from ITC; went over project last meeting/month in January; there was some back & forth, Keith & I had w/some questions; he finalized everything; good idea for Police Dept. I sent him I got February's bill today; I sent that to make sure there are no changes; compared to last comparison village board got; it looks like there is a \$6-8 diff.; not much of huge diff. between January comparison; February comparison & 1 I got today; there are a lot for benefits for us to move on w/system; I presented it to Board; Board hopefully has all of answers or all questions answered; it is a 5-yr. lease agreement; something we should have board approval there;

Mayor Bucco: We will be moving PD to Village Hall; how difficult would that be on your end & is there any add. Cost?

Keith: Because of nature of old facility; ITC is providing some equipment; that is basically a right to use to allow you to put latest equipment on older cabling so we are not putting any investment in old bldg. that's #1 & 2; easy to move but infrastructure meaning cabling, whenever you design offices in new space there's gonna have to be some cabling there so most likely there might be some additions you might have some more phones but this is designed to easily move from one facility to another across town or wherever ; has to be part of planning stages; as far as cabling you want to; we'd love to quote it;
