

VILLAGE BOARD WORK SESSION MEETING:

MAY 3, 2021

A Village Board Work Session Meeting took place on Monday, May 3rd, 2021 at 7:00 P.M. at Village Hall, 9 Fairlawn Drive, Washingtonville, News York, 10992.

PRESENT:

Mayor Bucco, Deputy Mayor Laudato, Trustee Kolar, Trustee Sampson, Trustee Calore.

ALSO PRESENT:

Washingtonville Police Chief Brian Zaccaro, DPW Superintendent Christopher Martino.

PLEDGE OF ALLEGIANCE TO THE FLAG – MAYOR BUCCO:

Mayor Bucco led the Pledge of Allegiance to the Flag.

ANNOUNCEMENTS – MAYOR BUCCO:

Posted 3 Positions for DPW Part-Time; starting salary is \$15.00 per hr.

Scheduling Public Hearing in July regarding new bldg. struct.; amounts for water & sewer, principal payment of \$295,000 & interest payment of \$89,296 due on Nov. 1, 2021. May 18th there will be a presentation of plans for New Village Hall.

Nxt. Mtg. May 18; Close Public Hearing & vote on Open Burning Law.

On Friday, received 1st Quarter Sales Tax from OC; \$249,222.74.

Today we had Comprehensive Zoning Mtg. Section 175 Zoning; Tomorrow at 10:00 is last 1 scheduled; May 11th at 3:00 P.M. & May 13th at 3:00 P.M.; need to set Public Hearing so we can present Comprehensive Plan, Public Mtg. & schedule Public Hearing.

RESOLUTION – INCREASE OF SALARY FOR CROSSING GUARD LINDA STEINBERGER:

Trustee Laudato made a motion, seconded by Trustee Sampson for approval of the increase of salary for the Crossing Guard, Linda Steinberger, from the pay of \$13.39 an hour to \$15.00 an hour. 5 Ayes, 0 Nays.

RESOLUTION – NEW SALARY OF CROSSING GUARD – EFFECTIVE MAY 6th, 2021:

Trustee Kolar made a motion, seconded by Trustee Sampson for approval of the Crossing Guard, Linda Steinberger, to start the increased salary of \$15.00 an hour effective May 6th, 2021. 5 Nays, 0 Nays.

RESOLUTION – SURPLUS OF OLD DPW EQUIPMENT – TRUSTEE KOLAR:

Surplusage of the IT Equipment, Trailer, Water Meters, Police Equipment;

Trustee Calore made a motion, seconded by Deputy Mayor Lang for approval of allowing the Surplus of the Old DPW Equipment. 5 Ayes, 0 Ayes.

NYPAC – FACILITY USE REQUEST – DANCE RECITAL:

Trustee Calore made a motion, seconded by Trustee Kolar for approval of the Facility Use Request for NYPAC to use Woodfield Park for the Dance Recital being held on the weekend of May 15th, 2021 and May 16th, 2021 from 9:00 A.M. – 5:00 P.M. and allowing Cornucopia, Ice Mother & NYPAC Club Truck to attend pending insurance. 5 Ayes, 0 Nays.

NYMIR – ONLINE TRAINING – TRUSTEE SAMPSON:

Bldg. Dept. Susan & John's email; put in request to IT Dept. to make up folders for them; separate; have them for NYMIR; have committees; ZBA, Planning; putting info. into them; training for them as well; May 7th, NYMIR will have new platform to offer all training; more info. to come once info. is up & running; admin. Training sessions but it is always during work sessions. All types of training.

DISCUSSION – MAYOR BUCCO – SPOKE W/HS PRINCIPAL BRIAN CONNOLLY:

Dates of May 10th, 2021 – June 10th, 2021; asked if students could park in the parking lot across the old municipal parking lot; I spoke to the Chief today; we could postpone of find another spot for whatever has to get done; truck inspections; it is an overflow lot because they are asking kids that go to BOCES to bring their cars in so that they can drive without using transportation because there are not enough bus drivers; cover up the 2 hour parking signs for that month; no crosswalk.

RESOLUTION – APPROVAL – USE OF PARKING LOT BY STUDENTS:

Trustee Sampson made a motion, seconded by Deputy Mayor Laudato for approval for the Washingtonville High School to Use the Parking Lot for Student Parking from the date of May 10th, 2021 to June 10th, 2021. 5 Ayes, 0 Nays.

RESOLUTION – TREE REMOVAL – 19 CONGRESS DRIVE GREEN AREA:

Deputy Mayor Laudato made a motion, seconded by Trustee Sampson for approval of three trees to be removed at the address of 19 Congress Drive in the Green Area not to exceed the price of \$1500.00. 5 Ayes, 0 Nays.

RESOLUTION – APPROVAL OF 1997 CHEVY DUMP TRUCK:

Trustee Sampson made a motion, seconded by Trustee Kolar for approval of the 1997 Chevy Dump Truck for the Department of Public Works. 5 Ayes, 0 Nays.

VERN ALLEN PARK – CURBING – TRUSTEE KOLAR:

Concrete is going to be cheaper option; probably would lose first few spots when you first come into the parking lot; three different spots that may be lost; needs to be done for safety; striping of parking lot is needed.

DISCUSSION – EMAIL REGARDING PAVING – MAYOR BUCCO:

They will be out there next week to survey Emerson, Secord & North St.; Chris and I met with Charlie Jones of Peckham Industries; They will run from Bull Rd all the way down to RT 94.

DISCUSSION – TRAFFIC PATTERN – NORTH STREET – MAYOR BUCCO:

I think the action right at the corner near “Stewarts” needs to be lessened; especially with school buses; meeting today with the Zoning Board that came up;

BZ: We can get a traffic counter, or we can get a radar sign; it gives us the daily # of cars and the times it runs, or we can get a road counter; the black strips.

DISCUSSION – SUMMER HELP FOR CLERICAL – TRUSTEE KOLAR:

They fill out the same Orange County Application that everyone fills out; building department paperwork/organization/rental registry.

RESOLUTION – EXECUTIVE SESSION:

Trustee Kolar made a motion, seconded by Trustee Sampson to end the work session, and enter the executive session. 5 Ayes, 0 Nays.
