### **RESOLUTION – GRANT FUNDING FOR WATER METERS – MAYOR BUCCO:**

#### WHEREAS,

The Village of Washingtonville, the village has continued to experience failure of its water meters at a higher rate each year requiring the use of estimated bills and manual readings which are an expense to the Village and;

#### WHEREAS,

The state has announced the availability of funding up to 75% (percent) of the cost for the acquisition and installation of an advanced metering infrastructure system for more efficient customer metering and the monitoring of inflow and infiltration through the green innovation grant program,

# WHEREAS,

Delaware Engineering, DPC, has been engaged by the Village for water improvement works and will prepare the consolidated funding application (CFA),

WHEREAS,

Such grant would be significant savings for water customers.

NOW THEREFORE, Being resolved by the Board of Trustees, HEREBY AUTHORIZES "Delaware Engineering" BPC to prepare a CFA Grant Application for a project as generally described in Exhibit 1 and confirms that the village will provide the 25% (percent) matching funds through direct expenditures.
