- C. Rofer called the meeting to order at 7:01PM and lead the pledge of allegiance.
- C. Rofer introduced Amy Fitzgerald, Senior Planner with Behan Planning & Design. A. Fitzgerald went through the maps she sent to us on Monday and explained them in detail.

Alma Gonzalez presented to the committee. Alma, Joanne Wiley and James Casazza have been working on the Natural Resources, Stormwater Management and Open Spaces. She went through the notes they shared with us (in the Shared Google Drive). They feel that signage is needed throughout the village to identify open spaces, memorials, etc. They want to create an open space inventory. They also want to identify ADA compliant areas.

- V. Laudato mentioned the video on the village website that shows an aerial view from a drone.
- A. Fitzgerald went through some of her thoughts on the village based on an outsider's perspective. She believes a challenge we face is that there are several vacant parcels with unknown ownership (based on Orange County ImageMate website). We need to clean this up so we know what we can do with these spaces. A. Fitzgerald went through the group's notes and gave her feedback.
- G. Lanzot asked if we will be trying to connect existing open spaces/trails to the rail trail. Yes.
- A. Fitzgerald went through her draft inventory.
- G. Lanzot asked if we are enveloped by water. A. Fitzgerald said yes because of the Moodna Creek- 100/500 year flood events. We have to know where the boundaries are and that any development near these areas would need to have special measures taken.
- D. Jacaruso mentioned that there is a liaison between FEMA and Kelly Roche from the DEC who can send flood maps.
- A. Fitzgerald continued: Spoke about Farms, Floods, Moffat Library, Drainage.
