The following Resolution was duly offered and seconded to wit:

Resolution authorizing Home Rule Request on behalf of the Village of Washingtonville regarding New York State Senate Bill Number S8725A and New York Assembly Bill Number A9690A.

WHEREAS, Chapter 206 of New York State Law of 2023 authorizes the Village of Washingtonville to issue Serial Bonds for the specific object or purpose of liquidating accumulated deficit for the General Fund - Sewer Fund Capital Project funds as of May 31, 2023 - Bonds as required that such Bonds be issued by November 30, 2024; and

WHEREAS, the determination has been made by the Village that additional time is needed to allow the Village to issue the Bonds authorized by Chapter 206 of the Law of 2023; and

WHEREAS, in order to facilitate the foregoing the Village must approve and submit Home Rule Request to the New York State Senate and New York State Assembly; and

WHEREAS, a Bill to facilitate the extension of the time to issue said Bonds has been introduced to the New York State Senate as Bill Number S8725A, and the New York State Assembly as Bill Number A9690A entitled an Act to Amend the Village of Washingtonville Deficit Financing Act in relation to the issuance of the certain Bonds; and

WHEREAS, the Village Board desires to express its support of said Bills to accomplish the Village objective and to approve this Home Rule Request.

THEREFORE, NOW, BE IT RESOLVED that:

Section 2. The Village Board hereby authorizes and approves this Home Rule Request to extend the date by which the Bonds must be issued and request the
